Action that is necessary to accept recommendation from HR Specialist Jayne McGee, Interim Fire Chief Adam Gardner, and Police Chief Kelley Johnson to amend Section 1.2.3 of the City of Sylacauga Policies and Procedures as adopted 12/1996, and further amended on 3/06/2002, 6/05/2013 and 7/19/2016, to change the residency requirement for personnel to the language cited below—Section 1.2.3 Residency shall be changed to read as follows:

City of Sylacauga Policies and Procedures, as adopted 12-1996 and amended on 3/06/2002, 6/05/2013, and 7/19/2016.

1.2.3 Residency:

Residency within the city's service area will not be required unless, in the judgment of the department head, the employee's job requires that he/she live within the area. However, all employees will be expected to be able to carry out the duties and responsibilities of their jobs. This may require that an employee live within a reasonable distance of his/her workstation. Fire and police personnel shall live within the corporate limits of the city, or within sixty (60) minutes lawful driving time of City Hall, by the most direct route. This requirement will not apply to part time Fire/Police personnel, Volunteer Fire personnel, or any currently employed at the time of adoption by the Council.

Action that is necessary to approve travel/expenses for Admin/Finance Accounting Clerk Sandy Sorensen to attend the Alabama Municipal Revenue Certification Training to be held in Tuscaloosa October 4-6, 2017—Registration fee is \$225.00; additional fees for lodging and meals will be incurred. Estimated total cost of travel/training for Sorensen is \$735.55:
