  - **A.1.** A step-raise should occur at the completion of entry level probation and every two years of continuous service thereafter, until the maximum step has been received within an employee's grade. No end of probation step-raise will be given for promotions and/or transfers.
  - **A.4.** With the exception of the step-raise provided at the completion of the entry level probation, all raises awarded will become effective at the beginning of the fiscal year in the year of completion of the specified years of service.
  - B. A step-raise may be recommended for employees that meet certain educational requirements, i.e.; certification pertinent to the specific job, college degree, etc., pertinent to employee's job and earned during employment with the City of Sylacauga.
